- Shelters 3 & 4 have twelve (12) tables each seating 6-8 people per table.

PERMIT FEES AND INFORMATION

MINGO CREEK PARK

Located 12 miles east of Washington off of Route 136. Open year round sunrise to sunset.

SHELTERS

- Reservations necessary.
- Beer permits issued with shelter rental only.
- No refunds if electric is out of service.
- All shelters have grills and trash receptacles nearby.
- Large shelters #'s 2,3,5,6,7,8,9 & 10 have 14 tables seating 6-8 people per table.
- Small shelters #'s 1 & 4 have 7 tables seating 6-8 people per table.
- All garbage is to be placed in dumpsters located near the shelters. Please bring your own bags.

PICNIC SITES

- Picnic tables are available on a first-come, first-serve basis throughout the park.
- No league play may be scheduled at any time for practice or league games in the county parks.

HORSEBACK RIDING

- Permits must be obtained in advance.
- Horseback riding is restricted to bridle trails only.
- Permits will be valid for the calendar year.

Non Fee Permit

GROUP CAMPING

- Only tent camping is permitted.
- Camping is restricted to organized groups, (i.e. Boy Scouts, Girl Scouts, 4-H, etc.)
- Camping is permitted year round.

FEES

Washington County Residents:
\$8.00 per night - up to 20 people.
Non-Residents:
\$10.00 per night - up to 20 people.

SPECIAL EVENT/ACTIVITIES

- A special event application must be submitted and approved by the Parks and Recreation Staff before a Special Event may be held in a Washington County Park.
- Special Events may include but aren't limited to: Fishing Tournaments, Bike Races, Walk-a-thons, Running Races and Festivals. Fees: \$50.00, \$250.00, \$500.00, \$1,000.00
- Certain activities within the County Park System also may require a permit or permission of the Parks & Recreation Staff. These activities may include but aren't limited to: Wedding Ceremonies, D.J.'s, Live Bands, Petting Zoos, Pony Rides, and Moonwalks.

TEN MILE CREEK PARK

Located off of Route 88 south of Fredricktown on Clarksville Road. Open year round from sunrise to sunset.

SHELTERS

- Reservations necessary.
- Beer permits issued with shelter rental only.
- Shelters 1 & 2 have 10 picnic tables seating 6-8 people per table, two electric outlets (110 volt) and grills.
- The Audia Shelter has 16 picnic tables seating 6-8 people per table, electrical outlets and grills.
- There are no refunds if electric is out of service.
