# Washington County CHIRP Program Final Report Summary

On Friday, February 5, 2021, Governor Tom Wolf signed into law legislation that set aside \$145 million in funds to aid hospitality industry businesses adversely affected by the COVID-19 pandemic. Specifically, the program requires counties to establish grant programs for eligible businesses. The initiative will be known as the “COVID-19 Hospitality Industry Recovery Program.”

Section 134-C of the Act of February 5, 2021 (No. 1), known as The Fiscal Code, establishes the County Block Grant - Hospitality Industry Recovery Program within the Department of Community and Economic Development (DCED). Per the formula set forth in the Act, Washington County was allocated \$2,343,028 to provide grants to eligible businesses in the food service and hospitality sectors. In accordance with the legislation, the County of Washington partnered with the Washington Industrial Development Corporation (WIDC), a Certified Economic Development Organization (CEDO), to administer the program. In turn, the WIDC partnered with the Mon Valley Alliance (MVA), another Washington County based CEDO to provide capacity for processing applications.

The WIDC and MVA worked to create county specific guidelines, application process, and website ([www.washcogrant.com](http://www.washcogrant.com)) and opened the program for applications on March 15, 2021. The program remained open through June 15, 2021, per the statutory requirements.

In total, 97 businesses were approved for funding, representing \$2,285,000 (or 97.5% ) in available CHIRP funds that were distributed to the food service and hospitality businesses of Washington County. The WIDC and MVA combined administration fees were \$58,028 (2.5%).

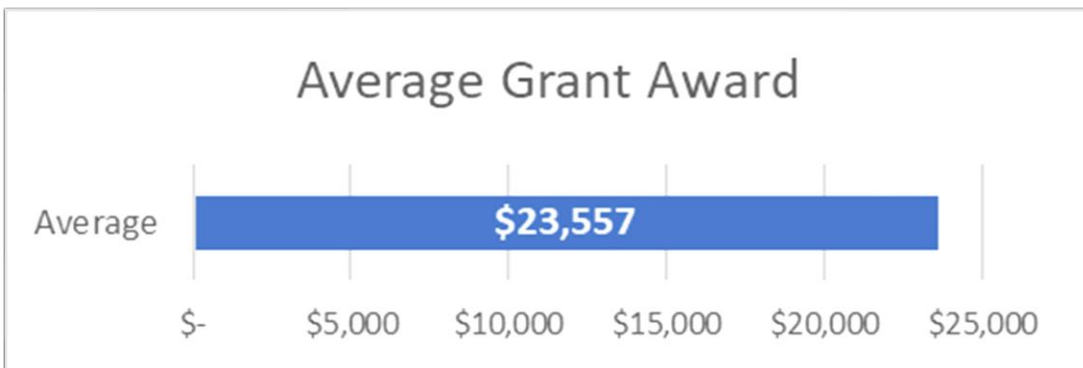
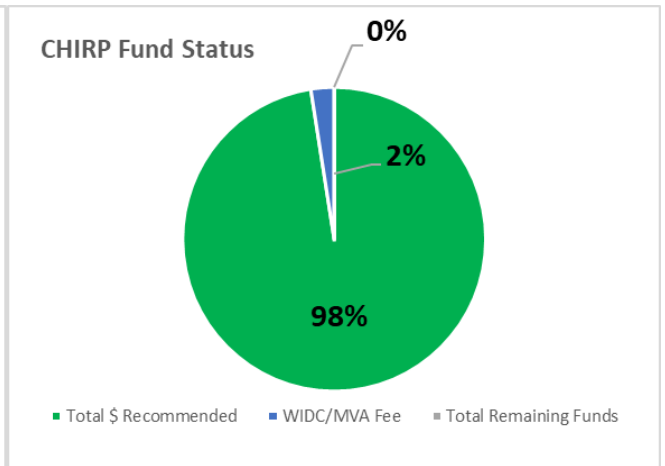
