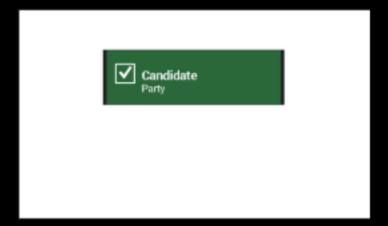


Help
