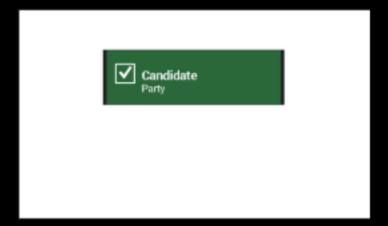


Help
