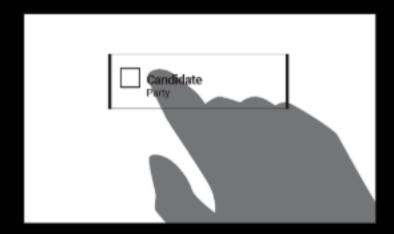
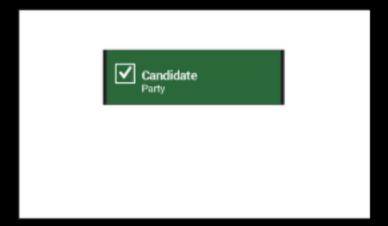


## Help

Return to Ballot




